WHEN TO APPLY

- Complete this form or apply online (bcit.ca/admission/apply). Be sure to complete every item.
- 2. Pay application fee (\$60 CDN for Canadian citizens/permanent residents and \$150 CDN for international applicants with study permit).
- 3. Mail (address above) or drop off this application along with your supporting documents to BCIT Student Information and Enrolment Services (building SW1).

#### **PAYMENT METHODS**

Please pay your application fee by cheque, money order, American Express, VISA or MasterCard. You can also pay by cash or debit card in person. Do not send cash through the postal system. A service charge for any NSF or returned cheque will be assessed.

You will receive a letter confirming receipt of your application within two weeks of your application date.

# To students currently attending secondary school

If you are currently attending high school, ask your Principal's Office to provide you with your marks for courses you have completed, interim marks for courses you are presently attending and a list of courses you plan to take in the future. Arrange to have your final official transcript sent directly to BCIT upon completion. Interim and final transcripts from the Ministry of Education may arrive at BCIT later than required.

# To those completing entrance requirements through upgrading courses

If you are attending or planning to attend courses that are required for your desired BCIT program, you must include proof of registration with your application form. It is essential that you keep the Admissions Department informed of your progress by sending interim transcripts or an official note from the course instructor. Upon completion of the course(s), arrange to have your official transcript(s) sent directly to your Admissions Officer at BCIT.

It is important that you submit your own copies of interim and final transcripts as soon as you receive them.

### TRANSCRIPT INFORMATION

You can submit a photocopy of a transcript if you do not have an official transcript available, so that processing of your application can begin.
- > BCIT requires official sealed transcripts if you are applying for a degree program, for course credit (after you have been accepted), or for advanced placement.

### USE OF PERSONAL INFORMATION NOTIFICATION

The personal information on this form is collected under the authority of the College and Institution Act (RSBC 1996, ch.52). BCIT will use and maintain the information for the purposes of admission, registration, research, alumni, and other fundamental activities related to delivery of programs and courses at BCIT. BCIT's administration calls for creating a digital photo image of each student that is used for purposes of validating the student as a member of the BCIT community to gain access to campus and services. The personal information will be used to verify the student Personal Education Number (PEN), required by the province of British Columbia, or to assign the PEN to students. The PEN is used to measure participation of the population in the post-secondary sector and for research and evaluation. For individuals granted awards, BCIT releases personal information to award donors, and provincial funding agencies. In addition, BCIT uses the name of the award winners and/ or photo images, municipality of residence, BCIT program name, and the name or criteria of any award won in marketing materials for the purpose of publicizing BCIT students, graduates, and their achievements.
